Information clause concerning correspondence with Interparking Polska Sp. z o.o.

If you intend to contact us and provide us with personal data, please find the information below regarding the rules of processing of such personal data.

In case of providing us with personal data, their controller shall be Interparking Polska Sp. z o.o. with its registered seat in Warsaw, ul. Św. Barbary 4/2, 00-686 Warszawa, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, XII Commercial Division of the National Court Register, under the number 0000138105, Tax ID: 5222420314, share capital PLN 20 200 000,00 ("Interparking").

Providing personal data is voluntary, but necessary for conducting correspondence, which involves processing of personal data for the purposes described below. Your personal data will be processed with appropriate security measures that meet the requirements of generally applicable Polish and EU law.

Depending on the situation, the basis for the processing of your personal data may be Article 6 sec. 1 letter a), b), c) or f) of Regulation (EU) 2016/679 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC ("GDPR"),

Your personal data will be processed for the following purposes (depending on the subject of the correspondence):

- 1. responding to correspondence received from you, including answers to questions asked and providing information you requested, as well as for handling further correspondence with you;
- 2. dealing with the matter you contacted us about;
- 3. sending marketing information (including commercial information), in particular sending information regarding products, contests, promotions, as well as invitations to events if you ask us to send such information by electronic means of communication, including by means of automatic calling systems and telecommunications terminal equipment to the provided e-mail address/telephone number (depending on what data was provided to us),
- 4. for other purposes related to the correspondence.

In addition, your personal data may also be used for analytical and statistical purposes, for direct marketing, for the purpose of pursuing or defending against claims - as part of the legally permitted and justified interest of the controller of personal data (Article 6(1)(f) of the GDPR).

The above purposes will be collectively referred to as "Processing Purposes".

Your personal data will be kept only for the period necessary for the proper implementation of the Processing Purposes. Within the scope of the consent for the processing of personal data, personal data will be stored until the consent is withdrawn or the activity to which the consent is related to is ceased. After the expiry of the above-mentioned periods, your data will be kept

for the periods provided for by law (if applicable) and for periods resulting from civil liability or public and administrative obligations of the controller related to the Processing Purposes.

The recipients of your data may be appropriate associates of the controller involved in the process of handling of your correspondence. In the case of marketing activities, the recipients of the personal data may be media houses, advertising agencies, entities providing marketing services, media administrators, internet portals, to the extent to which they participate in the controller's marketing activities.

In addition, your data may be made available to other entities, if their cooperation is justified by the Purposes of Processing (e.g. entities providing courier, banking, advisory, financial, accounting, tax, auditing, legal, IT services, hosting services, etc.) the extent to which these services may be related to the Purposes of Processing, as well as the processing of data in IT systems and resources and the operation of such systems and resources.

You have the right to: access your personal data, rectify it, delete it, limit processing, transfer data, the right to object to data processing due to your special situation or for direct marketing purposes and the right to withdraw consent to processing data at any time without affecting the legality of the current processing.
